# RETIREMENT TEXAS MUNICIPAL RETIREMENT SYSTEM (TMRS)

- Employee Contribution 7% Gross Wages.
- Employer Match 2 to 1
- 5 Year Vesting Period

# SERVICE RETIREMENT ELIGIBILITY

- Age 60 with 5 years of service.
- Any age with 20 years of service

# MISSION SQUARE -457 DEFERRED COMPENSATION

- Voluntary employee option
- No City contribution
- Income taxes are deferred until assets withdrawn.



# **ADDITIONAL BENEFITS**

## Vacation Leave

1-5 Years of Service - 10 days per year 6-10 Years of Service - 15 days per year 11+ Years of Service - 20 days per year

## Sick Leave

12 days a year

# Holidays

10 Paid Holidays: New Year's Day, President's Day, Memorial Day, 4th of July, Veteran's Day, Labor Day, Thanksgiving Day and the Day After, Christmas Eve and Christmas Day.

# Stability Pay

7 Years of Service - 3% of Annual Salary 8 Years of Service - 4% of Annual Salary 9 Years of Service - 5% of Annual Salary 10 Years of Service - 6% of Annual Salary

"TOTAL BENEFIT Package paid by CITY for Entry Level Public Works position Based on \$17.56/hr. -- Example: \$19,205.82 per/year or an additional \$9.23/hr. Does not include Stability Pay (min 7yrs service 3% annual)
